THE GAMING (AMENDMENT) REGULATIONS, 2022

Citation GN. No. 385 of 2003

1. These Regulations may be cited as the Gaming (Amendment) Regulations, 2022 and shall be read together with the Gaming Regulations, hereinafter referred to as the "principal Regulations" and shall come into effect on the 1<sup>st</sup> day of July, 2022.
